Investment strategy

IOOF Balanced Growth (MySuper investment option) gains its exposure to a diversified portfolio of investments through a mix of investment managers.

IOOF Balanced Growth provides a mix of growth and defensive assets which is weighted towards growth-focused assets (e.g. shares), with moderate exposure to defensive assets (e.g. cash).

A mix of passive, factor-based and active investment managers may be selected to manage the assets of IOOF Balanced Growth, providing differing, yet complementary, investment styles to achieve more consistent investment returns.

IOOF Balanced Growth is authorised to utilise approved derivative instruments for risk management purposes and investment efficiency, subject to the specific restriction that the derivative instruments are not used to gear portfolio exposure.

The underlying managers may utilise strategies for the management of currency exposure. It is the strategy of IOOF Balanced Growth that international currency exposure may be hedged.

Quarter highlights as at 30/09/2024

- A portfolio of unlisted infrastructure managers was added during the quarter as this asset class became a specific target allocation. Also added were MLC Opportunistic Capital Solutions and Barings in fixed income, while Muzinich was removed from fixed income and Macquarie was removed from Australian listed property.
- The alternative defensive portfolio, Insurance-related investments, and diversified fixed income portfolio outperformed.
- Global shares underperformed, with Alphinity and Royal London the major detractors. Unlisted property underperformed as challenging return to the office trends remain elevated, and office valuations fell during the quarter. An overweight allocation to Income Trust detracted value as the asset class had poor relative returns.
